PaveMend Purchase Considered High Priority for US Military

Environmental Solutions, Inc. is pleased to announce the sale of over 6500 units of PaveMend to the Defense Supply Center Richmond (DSCR). This purchase and subsequent orders will be utilized by 31 agencies that are involved with the support of Operation Iraqi Freedom in places to include Iraq and Afghanistan.

Environmental Solutions, Inc. is the exclusive distributor in the MidAtlantic region for PaveMend, a rapid return to service, repair material for concrete. The DSCR purchase included units of PaveMend SL, a self-leveling repair material with a fifteen minute set time and a return to service time within two hours, as well as PaveMend TR, a trowelable repair material with a 30 minute set time and return to service within three hours. Set time, strength, workability, and dependability are of the utmost importance for the intended applications of the product. For the DSCR purchase, PaveMend will be used specifically for airport runway repair and infrastructure repair on barricade walls and roadways.

PaveMend evolved as a result of Environmental Solutions, Inc.'s focus on the beneficial use of by-products (waste) to make high value, performance based, green products.
